In consideration of being permitted to participate in the following, the undersigned agree(s) as follows:

(1) **TRIPS OR ACTIVITY.** This release pertains to the student's participation in school sports programs, including practice, games, travel to and from games, and activities appurtenant to the sports programs. This release applies to all activities associated with basketball, cheerleading, volleyball, cross country, softball, baseball, golf, track and field or any and all other sports in which the student(s) may engage.

(2) **COVENANT NOT TO SUE.** In consideration of Outreach Christian Education (OCE), Gospel Center Inc. (GCI) providing the above service, I/WE COVENANT NOT TO SUE. Outreach Christian Education, Gospel Center Inc., their agents or employees, parents of students who volunteer into activities assigned by Outreach Christian Education, Gospel Center Inc., included but not limited to driving students other than their own to and from games, for any claim or cause of action that may have or hereafter acquire against any of them, arising out of the activity or any accident, injury, death, or property damage occurring thereon. This covenant not to sue shall be for me and for any minor child attending by my consent. In the event of an accident, injury, death or property damage occurring on this activity, the covenantor will never institute any action or suit at law or in equity against the covenantees nor institute, prosecute or in any way aid the institution or prosecution of any such claim, demand, action, or cause of action for damages, cost, loss of services, expenses, or compensation for or on account of any damage, loss of injury either to the person or property, or both; whether developed or undeveloped, or resulting or to result, known or unknown, past, present, or future, arising out of this activity. This covenant shall inure to the benefit of the covenantee(s) and his/her/their heirs and legal representatives. It shall bind the covenantor(s), the spouse of the covenantor(s), the covenantor(s)'s heirs and legal representatives. If another student chooses to ride with a teammate, OCE/GCI assumes no legal responsibility for students who drive other students. Nor does OCE/GCI assume any legal responsibility for parents who drive other children.

COVENANTOR HAS CAREFULLY READ THE FOREGOING COVENANT NOT TO SUE AND KNOWS AND UNDERSTANDS THE CONTENT THEREOF. THE UNDERSIGNED HAS (HAVE) EXECUTED THIS INSTRUMENT VOLUNTARILY AND WITH FULL KNOWLEDGE OF ITS SIGNIFICANCE.

(3) **INDEMNIFICATION.** The undersigned parent(s) or guardian(s) further covenant(s) and agree(s) to Outreach Christian Education, Gospel Center Inc., , their personal representatives, successors, assigns, heirs, officers, agents and employees from any expense, losses or damages (including legal fees), incurred as a result of claims made or demands hereafter made by any claimant(s) from an accident, injury death or personal property damage, or personal representatives or by third parties, or by their children, their heirs or assigns, or anyone acting for, by or through them, or acting for or by an estate of any person(s) attending or engaging in this activity.

(4) **RELEASE.** The undersigned as releasor(s), with the intention of binding himself/herself, his/her spouse, the child or children attending this trip or activity, their heirs, legal representatives, and assigns, expressly release(s) and discharges Outreach Christian Education, Gospel Center Inc., from all claims, demands, actions, judgments or damage that the releasor(s) ever had or now has, or may have, known or unknown, or that anyone claiming through or under him/her may have or claim to have, against the releasees, created by, arising from or out of the planned trip or activity and including all risk in connection therewith, whether arising foreseen or unforeseen.
